Ownership Changes/USA Patriot Act Notice

To add an owner, the signature(s) of the current owner(s) must be Signature Guaranteed and a specimen signature for the new owner is required along with their Social Security number, date of birth, current address, and phone number. **To remove an owner**, the signature of the owner to be removed must be Signature Guaranteed. **To remove an owner due to divorce**, the signature of the owner to be removed must have a Signature Guarantee. The divorce decree may be substituted only if the Ford Interest Advantage is specified as a part of the settlement. **To remove an owner due to death**, a certified copy of the death certificate, a completed W-9 form if the Social Security number will change and a letter of instruction signed by the surviving owner are required. **If the deceased is the only owner**, then the executor must sign the letter of instruction, obtain a Signature Guarantee, submit a certified copy of the death certificate and submit a copy of the certified letter of Testamentary or other letters of authority. Wills are not acceptable. **To change your name**, a copy of the marriage certificate, or original or certified copies of other legal documents substantiating the

name change, must be submitted. **To change a Social Security/Tax ID number** requires a completed W-9 form. **Additional Change Request forms** are available at ford.com/finance/investor-center/ford-interest-advantage or by calling 1-800-462-2614.

USA PATRIOT ACT NOTICE: To help fight the funding of terrorism and money-laundering activities, the U.S. government has passed the USA PATRIOT Act, which requires banks, including the Ford Interest Advantage processing agent bank, to obtain, verify, and record information that identifies persons who engage in certain transactions with or through a bank. Changing Registration of Ford Interest Advantage to a Trust Ownership

In order to change the registration of your Ford Interest Advantage to a trust ownership, complete the Authorized Signature Guarantee section with the name of the trust, Tax ID number, name of the trustee(s), and date of the trust. Please provide copies of the Trust that include the trust name, date of trust, the trustee(s), successor trustees, and the signature page. If the trustees are the same as the current Ford Interest Advantage owners, only an authorizing signature of the current Ford Interest Advantage owners is required to change the registration to a trust ownership on page 2. If the

trustees are not the current Ford Interest Advantage owners or if a current Ford Interest Advantage owner is being removed, the signature(s) of **ALL CURRENT FORD INTEREST ADVANTAGE OWNERS** must be guaranteed by a financial institution on page 2. The owner(s) to be removed must also complete the Ownership Change section. For additional trustees, please supply the same information as requested below. **NO P.O. BOX WILL BE ACCEPTED.**

Please be sure to provide your signature on both pages 1 and 2.

Documentation Definitions:

(1) Patriot Act Information: See Page 3 of the Change Form for full details.

(2) Medallion Signature Guarantee Stamp from a financial institution verifying your signature.

(3) Letter of Instruction: Letter containing note holder's name, note number and written request of specified changes to make to change the ownership type of the note.

(4) Letters of Testamentary: Certified court issued documents indicating legal executorship. Small Claims Affidavit: Document issued when the total assets fall under the dollar limit set by state statutes.
